This page of the RRC Membership Application highlights selected RRC Rules and Policies.**Safety:**

- Protective headgear and appropriate footwear is recommended for all riders and required for junior riders. Juniors must wear properly fastened protective headgear that meets or exceeds ASTM/SEI standards for equestrian use.
- Motorized Vehicles: may not be driven over the bridges. Minors who do not have a valid driver's license will not be permitted to operate a motorized vehicle of any kind including, but not limited to, golf carts, motorcycles, scooters or farm utility vehicles on the Rancho Riding Club grounds at any time. The speed limit while on the Rancho Riding Club grounds is 5 mph. RECKLESS DRIVING OF ANY MOTORIZED VEHICLE BY ANYONE ON THE CLUB GROUNDS WILL BE SUBJECT TO A FINE OF \$250.00 AND EXPULSION FROM THE GROUNDS.
- DOGS ARE NOT PERMITTED ON THE RANCHO RIDING CLUB GROUNDS.
- HORSES HAVE PRIORITY AND THE RIGHT-OF-WAY. Use caution and courtesy when approaching horses and riders: when riding, pass on the left, if on foot, approach, at a walk, so that horse and rider can see you.
- GUESTS of RRC members are welcome when accompanied by the member. We remind Members that to have their guest sign a Release and Hold Harmless Agreement at the manager's office.

Trail Riding:

Per the Rancho Santa Fe Association's policy, non-Covenant RRC members riding on RSF trails must be accompanied by a member of the Rancho Santa Fe Covenant.

RANCHO RIDING CLUB Equestrian Release, Assumption of Risk, Waiver and Indemnification

This document waives important legal rights. Read it carefully before signing.

I agree in consideration for my participation in equestrian activities at the Rancho Riding Club to the following:

1. I agree that I choose to participate voluntarily in equestrian activities with my horse, as a rider, handler, owner, agent, coach, trainer, or as a parent or legal guardian of a junior participant. I am fully aware and acknowledge that horse sports and participation in equestrian activities involve inherent risks of accident, loss and serious bodily injury, including broken bones, head injuries, trauma, pain, suffering, or death ("Harm").
2. I agree to release the Rancho Riding Club from all claims for money damages or otherwise for any Harm to me or my horse and for any Harm caused by me or my horse to others, even if the Harm resulted, directly or indirectly, from the negligence of the Rancho Riding Club.
3. I agree to expressly assume all risks of Harm to me or my horse, including Harm resulting from the negligence of the Rancho Riding Club.
4. I agree to indemnify (that is, to pay any losses, damages, or costs incurred) by the Rancho Riding Club and to hold it harmless with respect to claims for Harm to me or my horse, and for claims made by others for any Harm caused by me or my horse at the Rancho Riding Club.
5. I understand that the Rancho Riding Club encourages me to wear protective equipment while WARNING that no protective equipment can guard against all injuries.
6. If I am a parent or legal guardian of a junior participant, I consent to the child's participation and Agree to assume all of the obligations of this Release on the child's behalf.
7. I agree that "Rancho Riding Club" as used above includes all officers, directors, employees, agents, personnel, volunteers and affiliated organizations¹.
8. I agree that if I am injured at the Rancho Riding Club facility, the medical personnel treating my injuries may provide information on my injury and treatment to the Rancho Riding Club.

I represent that I have, or am acquiring, the requisite training, coaching and abilities to safely ride at this facility.

By signing below, I agree to be bound by the Rules and Policies and Bylaws of the Rancho Riding Club and all terms and provisions of this application. I certify that all family members included in this membership are named on this application.
